The following events have been carried out within this project:

Event 1: Management and preparatory activities

Participation: The event involved 24 project coordinators from all participating organizations, including 4 participants from the city of Caltanissetta (Italy), 2 participants from the city of Lefkosia (Cyprus), 2 participants from the city of Liege (Belgium), 2 participants from the city of Paris (France), 1 participant from the city of Berlin (Germany), 1 participants from the city of Tartu (Estonia), 2 participants from the city of Athens (Greece), 1 participants from the city of Siauliai (Lithuania), 1 participant from the city of Riga (Latvia), 1 participant from the city of Kumanovo (Former Yugoslav Republic of Macedonia), 2 participants from the city of Lisbon (Portugal), 1 participant from the city of Cluj Napoca (Romania), 1 participants from the city of Stropkov (Slovakia), 1 participant from the city of Hódmezővásárhely (Hungary), 4 participants from the city of Varna (Bulgaria).

Location/ Dates: The event took place on-line through Skype meetings, from 23/03/2015 to 03/04/2015.

Short description: Skype meetings have been organised between Prism and project coordinators from all partner organizations. The preparatory meetings aimed: to reach a common understanding of the project and its idea; to share aims and objectives of the project; to clarify the work plan and the main phases of the project; to introduce common criteria for selection of participants; to agree on financial conditions. Management tools have been developed and shared among all partner organizations.

Event 2: International workshop on "Migration, integration and co-development in Europe"

Participation: The event involved 40 citizens, including 2 participants from the city of Lefkosia (Cyprus), 2 participants from the city of Liege (Belgium), 2 participants from the city of Paris (France), 2 participants from the city of Berlin (Germany), 2 participants from the city of Tartu (Estonia), 1 participant from the city of Athens (Greece), 2 participants from the city of Siauliai (Lithuania), 2 participants from the city of Riga (Latvia), 2 participants from the city of Kumanovo (Former Yugoslav Republic of Macedonia), 2 participants from the city of Lisbon (Portugal), 2 participants from the city of Cluj Napoca (Romania), 2 participants from the city of Stropkov (Slovakia), 2 participants from the city of Hódmezővásárhely (Hungary), 2 participants from the city of Varna (Bulgaria), 10 participants from the city of Caltanissetta (Italy).

Location/ Dates: The event took place in Caltanissetta, Italy from 8/05/2015 to 10/05/2015.

Short description: The event aimed to share information on the current European scenario on migration and asylum. The agenda included: The European scenario on migration and asylum. Forum space: scenarios and experiences in each participating country. The European policies on Migration and Asylum: the European directives, the Treaty of Lisbon, the Dublin Regulation, the EASO "European Asylum Support Office" and the "CEAS- Common European Asylum System. AMIF - Asylum Migration Integration Fund 2014/2020. Vulnerable groups: victims of violence and torture, other targeted groups. Practices and experiences on the field: the role of

intercultural mediation, social innovation for integration, the protection of unaccompanied foreign minors. Co-development workshops: new perspectives on shared policies.

Event 3: Gathering data on public opinion, the online survey

Participation: All partner organizations informed and involved respondents from their European, national and local networks to participate in the survey. In total, N. 844 questionnaires were completed.

Location/ Dates: The on-line survey was launched in all participating countries between June 2015 and January 2016.

Short description: A relatively short questionnaire was developed and spread across all participating countries in order to gather individual opinions on perception about the phenomenon of migration and feedbacks about current policies on migration and asylum policy from citizens of all participating countries. All partner organizations informed and involved respondents from their European, national and local networks to participate in the survey.

Event 4: The final international seminar “A common European migration policy”

Participation: The event involved 40 citizens, including 2 participants from the city of Lefkosia (Cyprus), 1 participant from the city of Liege (Belgium), 2 participants from the city of Paris (France), 2 participants from the city of Berlin (Germany), 2 participants from the city of Tartu (Estonia), 2 participants from the city of Athens (Greece), 2 participants from the city of Siauliai (Lithuania), 2 participants from the city of Riga (Latvia), 2 participants from the city of Kumanovo (Former Yugoslav Republic of Macedonia), 2 participants from the city of Lisbon (Portugal), 2 participants from the city of Cluj Napoca (Romania), 2 participants from the city of Stropkov (Slovakia), 2 participants from the city of Hódmezővásárhely (Hungary), 2 participants from the city of Varna (Bugaria), 10 participants from the city of Caltanissetta (Italy).

Location / Dates: The event took place in Caltanissetta, Italy from 3/10/2015 to 4/10/2015.

Short description: The aim of the event was to share and develop common recommendations on a common European policy on migration and asylum. The agenda included: The project “Migration, Integration and Co-development in Europe”. Refugee crisis: Migration to Europe explained in graphics. From migration’s causes to integration: the European agenda. Monitoring the implementation of the migration policy: data, corruption and recommendations. Migratory routes to Europe: testimonials by “Migranti solidali” from Afghanistan, Baluchistan, Kashmir and Ghana. Forum space: presentation of recommendations by national delegations. A European Citizens' Initiative: a shared EU policy on migration and asylum.

Event 5: Recommendations in the areas of asylum and migration

Participation: Local stakeholders were consulted in all participating countries and local communities..

Location / Dates: The event took place in Caltanissetta, Italy from 3/10/2015 to 4/10/2015.

Short description: Both partner organizations and participants have been invited to discuss and debate issues from the European political agenda in the areas of asylum and migration in order to develop possible recommendations. Final recommendations have been developed by comparing diverse perspectives from a broad range of citizens spanning 15 European countries with vast differences in the perception of the phenomenon as well as in migration policy traditions.
